Superintendent's Corner



As the summer draws to an end and final preparations for the coming school year are finalized, take a moment to pause and reflect on the many good things life has to offer. Whether you are a parent shopping for school clothes and supplies, a student eager to discover the challenges of the next grade, a community member gearing up for the rumble of yellow school busses or even a staff member putting the finishing touches to their classroom to make it the most inviting place for students, North Branch Area Schools has a lot to be proud of.

Student achievement is the number one priority. We are a learning community dedicated to excellence and believe our children come first. The entire staff of NBAS is committed to *insuring* all students are college and career ready when they graduate. This summer, teachers have been busy pouring over curriculum to align it with the Common Core State Standards. The Common Core State Standards provide a consistent, clear understanding of what students are expected to learn, so teachers and parents know what they need to do to help them. The standards are designed to be robust and relevant to the real world, reflecting the knowledge and skills that our young people need for success in college and careers.

The transportation department has been industriously preparing the busses for another year, custodians have the buildings in beautiful condition and the food service group has wrapped up the summer breakfast and lunch program and is ready to feed the student's breakfast and lunch throughout the school year with no increase in lunch prices. Our child care program, FABS (Fun After and Before School) operated all summer at full capacity. Many coaches have already begun practices for fall sports and the Bronco Marching Band completed their annual weeklong Marching camp the first week of August. Let's not forget about the Band Boosters and Athletic Boosters. These are groups that provide tremendous support for our student programs and are a significant reason why North Branch Area Schools is one of the few left which does not charge participation fees for student athletes.

The Board of Education has established a Strategic Plan to guide the district through the next five years. One of the goals is to "Use the district's financial resources to provide the best educational services possible for students while maintaining financial stability." The Board of Education, in cooperation with all employee groups, was able to align revenues and expenses for the first time since 2006. The balanced budget maintains all programs and services for our students. In some cases such as full-day kindergarten, the Board has actually expanded programs for kids while still tightening the budget.

The first half-day of school for students is September 4. All student programs and services are fully operational and Bronco Pride is abundant! I want to express my thanks for your continued support of our schools. Working together, we can continue providing the high level of educational opportunities for our children. North Branch Area Schools is proud to be a part of a caring community that believes "kids come first." Feel free to reach out to any staff member with questions or concerns. The administrative team is ready to address any issues prior to the start to school. Further, consider checking out the district's updated website to discover specific information as it relates to your child. Have a great rest of the summer. I'll see the students bright and early September 4!

NBHS graduates will be entering the Military via Officer Training programs

2012 graduate, Matthew Haney was selected into the Naval Reserve Officer Training Corps based on his ACT scores. The highly selective application process involves an extensive written application and an inter-

view with a Navy representative. Applicants must also pass an entrance medical examination process. Matt will be studying at the University of Michigan in Ann Arbor pursuing a degree in Naval Architecture. He has a trial first year with the NROTC program after which he may elect to commit to the Navy or not. Should he decide to continue, Matt would serve as a reservist for the duration of college and then serve the Navy as an officer full time for five years after college. When his active duty has been completed, Matt plans to go into the private sector designing ships for the Navy (they no longer build their own but use civilian contractors).

Eli Parsch is graduating for the second time this summer, recently from NBHS and the other will be from basic training at U.S. Air Force Academy in Colorado the 1st of September. He and his platoon are currently in the wilds of Colorado doing the physical part of boot camp. Although not allowed contact from his family and friends during this time, he told his mother (Cathy Parsch) previously that the Academy is the "hardest thing" he's ever done, but "this is where he is meant to be." He is one of a very small percentage that is accepted into the Air Force Academy. More than 15,000 people apply each year and only 1000 get accepted, Mrs. Parsch said.

"Usually 1500 are accepted, but because of budget cuts, the selection process is even tighter this year," she said.

"Eli has been in preparation for the past four years for this training. He started talking about it in the 8th grade. In 9th grade he spoke to a friend of ours, Steve, who went through the training and is retired," she said. "In 10th grade, he made the decision and they have been watching him ever since."

Acceptance is based on 60% academic,

not only his grades but also his ACT and SAT scores; 20 % community service such as his church and National Honor Society and 20 % leadership. Eli was the vice president of his class for his junior and senior year

and a member of Student Council all four

"Steve gave him some advice about his high school sports, too. Eli had always loved track, but Steve suggested that he joined a team sport because the Air Force wants to know you can train and function with a team. So in 10th grade, Eli went out for football," she said. "When the coach talked to the team about eligibility, Eli volunteered to help tutor, not only that year, but for future years, too."

Mrs. Parsch said that the best part about that experience for Eli was getting to know classmates that he might not have ever known. Coach Jacobson told Eli he was a great teammate, not necessarily because of his athletic ability, but because of his willingness to do whatever it took to help the team, she said. He filmed for the team his senior year, she said.

Congresswoman Candice Miller could only nominate two candidates from the State of Michigan. She told Eli her panel of interviewers was "blown away" by Eli's maturity and demeanor in personal panel interviews, Mrs. Parsch explained. "Sometimes he had as many as six people interviewing him."

"They were also impressed not only by his academics and service, but also that he has been working since he was 13 years old, milking cows for the Sohn's," she said. "It shows his work ethic."

The end result of this training is that Eli will be "doing something for his country," Mrs. Parsch said. He hopes to become a

Eli is the only son of Cathy and John Parsch of North Branch and the only brother of Madalyn Parsch, a 2007 graduate of North Branch High School. His first trip home will hopefully be at Christmas, Mrs. Parsch said.


NEW TEACHERS

Access to Student Directory Information

HIGH SCHOOL NEWS

New High School Schedule

Beginning this fall, North Branch High School students will follow a 3 by 6 schedule. This means that students will attend six classes per day for each of the three trimesters. Each class period will last 60 minutes. All core classes (English Language Arts, Math, Science and Social Studies), will meet all year long (3 trimesters) which will allow for more time for student learning. In addition to more time in the classroom, there will also be fewer scheduled gaps between courses as sometimes happened in the 3 by 5 trimester schedule that we have been using.

The Leadership Team at North Branch High School, as part of our School Improvement Process, reviewed the current 3 by 5 high school schedule and evaluated alternatives to assure optimal student learning. The committee used the following criteria in making their recommendation.

- Maintains or exceeds the amount of learning time per course
- Decreases the amount of gap time between courses.
- Meets the Michigan Core Curriculum standards and is aligned to the National Common Core Standards as well as the College and Career Readiness standards as developed by ACT.
- Ensures a comprehensive program of study that also allows for student choice
 - Schedule is programmatically and fiscally sustainable over time.

The committee researched several different High School Models. The schedule that makes the most sense and best meets the criteria above is the 3 X 6 Trimester Schedule. This new schedule will have the following benefits:

- More emphasis on core courses
- Provides opportunity for year-long courses in all core academic areas
- Reduces the gaps between core courses
- Maintains comprehensive high school program and allows students to take electives
 - A continuation of current junior high schedule
 - Cost effective schedule

2011-2012 Recap

The North Branch Athletic Department is looking forward to a great 2012-2013 athletic year, but let's first look back at the accomplishments of last year. In the fall, the volleyball team lost its first league match in eight years and finished second in the TVC East Division. However, the team won its 5th consecutive TVC Conference Tournament Championship and its seventh consecutive District Title. The Lady Broncos advanced to the Regional Finals before losing a heart-breaking match to league rival Frankenmuth in five sets. North Branch finished the season ranked #7 in Class B and 54-17-1 overall. In addition, the team received Academic All-State recognition for the sixth consecutive year with an overall team grade point average of 3.61 while Sam Garza and Taylor Cheney earned Individual Academic All-State honors. The varsity football team finished in a third place tie in the very tough TVC East Division while dressing only 14 seniors this past season. North Branch finished 9th in Division Four with the highest team academic grade point average for its top 11 players (3.81) and Eli Parsch earned Honorable Mention Individual Academic All-State. The following individuals received first team all-conference recognition in the fall: Ryan Garza (Cross Country), Garrett Washington (Boys' Soccer), Trevor Marceau at defensive back and at wide receiver (Football), and Rachel Fish and Sam Garza (Volleyball). In addition, Sam Garza earned second team All-State recognition and Rachel Fish received Honorable Mention All-State Honors. Also during the fall season, North Branch had 112 out of 182 student-athletes (61.54%) receive scholar-athlete awards for a 3.2 or high grade point average.

During the winter season, the wrestling program had great success finishing 24-10 for its second consecutive winning season. North Branch finished in third place in the TVC East Division and will return 21 of its 24 wrestlers next year. The competitive cheer team finished in second place in the TVC West Division for the second consecutive season. The varsity boys' basketball team advanced to the District Championship game after a thrilling upset over Croswell-Lexington in the District Finals. The following individuals received first team all-conference recognition: Jessica Laur and Victoria Seaman (Competitive Cheer), Candace Sutter (Girls' Bowling), Brandon Berlin (Boys' Bowling), and Ben Fowler (Wrestling). Also, the Broncos advanced four wrestlers to the Individual Regional Tournament in Lawrence Abbey, Ryan

Garza, Zeke Shifflett, and Ruben Thomas with Ryan Garza advancing to the Individual State Finals. During the winter season, North Branch had 74 out of 130 studentathletes (56.92%) receive scholarathlete awards for a 3.2 or higher grade point average. In the spring season, the girls'

soccer team finished 13-8-2 for its ninth consecutive winning season and 7-6-1 in the TVC good for a third place tie. The team defeated Flint Northwestern and Flint Kearsley to advance to the District Finals. Also, varsity baseball team finished 18-17 on the season with just two seniors on its team. Both the baseball and softball teams finished 6-6 in the TVC East Division good for third place finishes while the boys' track team also finished in third place in the TVC East Division. The following individuals received first team all-conference recognition: Mike Berlin and Garrett Washington (Baseball), Megan Shaw and Kalee Sevon (Softball), Karisma Leon (Girls' Soccer), Aaron Fielder (Boys' Track). Finally, during the spring season, a very impressive 112 out of 162 student-athletes (69.1%) received the scholar-athlete award for a 3.2 grade point average or higher.

2012 Fall Preview

It has been a very busy summer at the high school as the vast majority of the teams and athletes have been working hard to prepare for the 2012-2013 year. Many of our athletes have participated in strength training, camps, and scrimmages. The football team has participated in several 7-7 scrimmages and hosted two camps. The boys' and girls' soccer teams held camps and participated in leagues during the summer. The girls' basketball team hosted several scrimmages with various schools. The boys' basketball team played in a summer league, traveled to a team camp, and hosted a skills camp. The cheerleading teams practiced throughout the summer and utilized the fitness center. The volleyball program hosted a camp and participated in a summer tournament. Many wrestlers traveled to camps or participated in open gyms. The cross country runners have been training 2-3 times a week all summer. Many of our baseball and softball players haven been playing on travel teams since early June. The coaches and athletes are very excited for what could be an outstanding athletic year at North Branch as the Broncos will be in contention for several league and district titles.

Football: The 2011 season finished with the Broncos going 4-5 overall for the second consecutive season. Coach Pat Forster will enter his fourth season as the varsity coach with a 14-14 overall record and one playoff appearance. The Broncos return 18 letter winners from last year's team as well as some talented athletes from the 5-4 JV team. The season opener will be on Friday, August 24 at Imlay City with kickoff at 7:00 p.m. with the home opener on Thursday, August 30 vs. Garber. The Broncos will play 3 other home games this year including Birch Run on September 21 Wounded Warriors Game and Light's Out Band Performance), Holly on October 5 (Homecoming), and Yale on October 19 (Senior Night and Band Parent Night). Season passes for all home football games will be on sale in the athletic office during regular school hours and at all home football games.

Boys' and Girls' Cross Country: Wayne Haney will take over the reins of the boys' and girls' cross country teams. Both squads have been running all summer and are optimistic about fielding two competitive teams. The boys' team could have 6 returning runners while the girls' team will have 3 returning letter winners. Both teams finished in 5th place in the TVC East Division last year and are hopeful of finishing in the upper half of the TVC this season. North Branch will host the Lapeer County Meet on Tuesday, September 18 with races beginning at 4:00 p.m. and the final TVC East Jamboree on Tuesday, October 9 with races starting at 4:30 p.m.

Cheerleading: Kelli Lovasz will take over the fall sideline cheer program. Coach Lovasz is an experienced coach and could be looking at returning 15 letter winners from last year's squad. The team had an outstanding summer and is extremely important in creating a spirited atmosphere at our athletic events. Look for news about the cheerleading program on its web-page which has a link on the North Branch Athletic home page.

Boys' Soccer: Rick Skelton has returned to take over the boys' soccer program. Last year's team finished with an 8-12-1 overall record and 4-8-1 conference record earning the team a fifth place finish in the TVC East Division. The squad graduated 6 players with varsity experience and will return 10 letter winners. North Branch will open up at home on Friday, August 17 vs. Armada at 4:30 p.m. Staring September 10 against league rival Frankenmuth, North Branch will play 5 out of 6 games at home. With beautiful fall weather anticipated, this would be a great time to take in a few Bronco soccer matches.

Volleyball: The Lady Broncos only lose 3 seniors from last year's 54-17-1 Regional Runner-Up team and return 10 players with varsity experience. Coach Jim Fish returns for his 13th season with an overall record of 672-118-36. The varsity team will host two tournaments this year with the first one on Thursday, August 23 and the second one on Saturday, October 20. The Lady Broncos will also host Quads on August 28 and October 10. League rival Frankenmuth will visit North Branch on Wednesday, September 12. North Branch will host the Class B District Tournament the week of October 29.

The first booster meeting of the year was held on Monday, August 6th in the high school media center. Ruth Fox Elementary Receives Foundations Literacy Project Grant

Ruth Fox Elementary is the proud recipient of a generous literacy grant from the Foundations Literacy Project (a **HIS Life Foundation** and **Stebbins Family Foundation** partnership). This grant focuses on "tweens", with the aim of closing the achievement gap in literacy skills through innovative summer learning experiences. Ruth Fox Elementary received a total of \$11,568.00.

A significant portion of this grant was used to purchase eleven iPads, a synching tray, protective casing and keyboards. Research suggests summer reading loss can be prevented if students read 4 to 5 appropriately challenging books over the summer (Kim 2004), so remaining monies were used to boost summer literacy skills by purchasing books to build forty at-home student libraries (students were selected using a random number generator) and to put on a four week Summer Institute.

Students attending the Institute participated in numerous interactive literacy and math lessons connected to the theme of "Fitness". Students had several guest speakers, participated in a cardio fitness class at Dragon Karate with Master Cousineau, made purchases at a bookstore, and Skyped with tween author, Ellen Potter, and two Junior Michigan Olympians, Bethany and Laya Hartman. Throughout the Institute, students gained proficiency in various digital tools and resources—Diigo, Evernote, GoogleDocs, ScreenChomp, Popplet Lite, and more—while learning fundamental skills and concepts along the way. In the upcoming school year, students involved in the Institute

will have opportunities to share their digital creations and knowledge with peers, Ruth Fox staff members, and on the World Wide Web.

Ruth Fox Elementary is grateful to the **Stebbins Family Foundation** and **HIS Life Foundation** for their substantial literacy contribution. 



Bullying And Other Aggressive Behavior Toward Students

It is the policy of the District to provide a safe and nurturing educational environment for all of its students. This policy protects all students from bullying/aggressive behavior regardless of the subject matter or motivation for such impermissible behavior. Bullying or other aggressive behavior toward a student, whether by other students, staff, or third parties, including Board members, parents, guests, contractors, vendors, and volunteers, is strictly prohibited. This prohibition includes written, physical, verbal, and psychological abuse, including hazing, gestures, comments, threats, or actions to a student, which cause or threaten to cause bodily harm, reasonable fear for personal safety or personal degradation.

Demonstration of appropriate behavior, treating others with civility and respect, and refusing to tolerate harassment or bullying is expected of administrators, faculty, staff, and volunteers to provide positive examples for student

This policy applies to all "at school" activities in the District, including activities on school property, in a school vehicle, and those occurring off school property if the student or employee is at any school-sponsored, schoolapproved or school-related activity or function, such as field trips or athletic events where students are under the school's control, or where an employee is engaged in school business. Misconduct occurring outside of school may also be disciplined if it interferes with the school environment.

Notification: Notice of this policy will be annually circulated to and posted in conspicuous locations in all school buildings and departments within the District and discussed with students, as well as incorporated into the teacher, student, and parent/guardian handbooks. State and Federal rights posters on discrimination and harassment shall also be posted at each building. All new hires will be required to review and sign off on this policy and the related complaint procedure.

Parents or legal guardians of the alleged victim(s), as well as of the alleged aggressor(s), shall be promptly notified of any complaint or investigation as well as the results of the investigation to the extent consistent with student confidentiality requirements. A record of the time and form of notice or attempts at notice shall be kept in the investigation file.

To the extent appropriate and/or legally permitted, confidentiality will be maintained during the investigation process. However, a proper investigation will, in some circumstances, require the disclosure of names and allegations. Further, the appropriate authorities may be notified, depending on the nature of the complaint and/or the results of the investigation.

Implementation: The Superintendent is responsible to implement this policy, and may develop further guidelines, not inconsistent with this policy. This policy is not intended to and should not be interpreted to interfere with legitimate free speech rights of any individual. However, the District reserves the right and responsibility to maintain a safe environment for students, conducive to learning and other legitimate objectives of the school program.

Procedure: Any student who believes s/he has been or is the victim of bullying, hazing, or other aggressive behavior should immediately report the situation to the Principal or assistant principal. The student may also report concerns to a teacher or counselor who will be responsible for notifying the appropriate administrator or Board official. Complaints against the building principal should be filed with the Superintendent. Complaints against the Superintendent should be filed with the Board President.

Every student is encouraged, and every staff member is required, to report any situation that they believe to be aggressive behavior directed toward a student. Reports shall be made to those identified above. Reports may be made anonymously, but formal disciplinary action may not be taken solely on the basis of an anonymous report.

The Principal (or other administrator as designated) shall promptly investigate and document all complaints about bullying, aggressive or other behavior that may violate this policy. The investigation must be completed as promptly as the circumstances permit and should be completed within three (3) school days after a report or complaint is made.

If the investigation finds an instance of bullying or aggressive behavior has occurred, it will result in prompt and appropriate remedial action. This may include up to expulsion for students, up to discharge for employees, exclusion for parents, guests, volunteers and contractors, and removal from any official position and/or a request to resign for Board members. Individuals may also be referred to law enforcement or other appropriate officials.

The individual responsible for conducting the investigation shall document all reported incidents and report all verified incidents of bullying, aggressive or other prohibited behavior, as well as any remedial action taken, including disciplinary actions and referrals, to the Superintendent. The Superintendent shall

submit a compiled report to the Board on an annual basis.

Non-Retaliation/False Reports: Retaliation or false allegations against any person who reports, is thought to have reported, files a complaint, participates in an investigation or inquiry concerning allegations of bullying or aggressive behavior (as a witness or otherwise), or is the target of the bullying or aggressive behavior being investigated, is prohibited and will not be tolerated. Such retaliation shall be considered a serious violation of Board policy, independent of whether a complaint of bullying is substantiated. Suspected retaliation should be reported in the same manner as bullying/aggressive behavior.

Making intentionally false reports about bullying/aggressive behavior for the purpose of getting someone in trouble is similarly prohibited and will not be tolerated. Retaliation and intentionally false reports may result in disciplinary action as indicated above.

Definitions: The following definitions are provided for guidance only. If a student or other individual believes there has been bullying, hazing, harassment or other aggressive behavior, regardless of whether it fits a particular def-

inition, s/he should report it immediately and allow the administration to determine the appropriate course of action.

"Aggressive behavior" is defined as inappropriate conduct that is repeated enough, or serious enough, to negatively impact a student's educational, physical, or emotional well-being. Such behavior includes, for example, bullying, hazing, stalking, intimidation, menacing, coercion, name-calling, taunting, making threats, and hitting/pushing/shoving.

"At School" is defined as in a classroom, elsewhere on school premises, on a school bus or other school related vehicle, or at a school-sponsored activity or event whether or not it is held on school premises. It also includes conduct using a telecommunications access device or telecommunications service provider that occurs off school premises if either owned by or under the control of the District.

"Bullying" is defined as any gesture or written, verbal, graphic, or physical act (including electronically transmitted acts – i.e. internet, telephone or cell phone, personal digital assistant (PDA), or wireless hand held device) that, without regard to its subject matter or motivating animus, is intended or that a reasonable person would know is likely to harm one (1) or more students either directly or indirectly by doing any of the following:

A. substantially interfering with educational opportunities, benefits, or programs of one (1) or more students;

B. adversely affecting the ability of a student to participate in or benefit from the school district's educational programs or activities by placing the student in reasonable fear of physical harm or by causing substantial emotional distress;

C. having an actual and substantial detrimental effect on a student's physical or mental health; and/or

D. causing substantial disruption in, or substantial interference with, the orderly operation of the school.

Bullying can be physical, verbal, psychological, or a combination of all three.

Some examples of bullying are: A. Physical – hitting, kicking, spitting, pushing, pulling; taking and/or damaging personal belongings or extorting money, blocking or impeding student movement, unwelcome physical contact.

B. Verbal – taunting, malicious teasing, insulting, name calling, making

C. Psychological – spreading rumors, manipulating social relationships, coercion, or engaging in social exclusion/shunning, extortion, or intimidation. This may occur in a number of different ways, including but not limited to notes, emails, social media postings, and graffiti.

"Harassment" includes, but is not limited to, any act which subjects an individual or group to unwanted, abusive behavior of a nonverbal, verbal, written or physical nature, often on the basis of age, race, religion, color, national origin, marital status or disability, but may also include sexual orientation, physical characteristics (e.g., height, weight, complexion), cultural background, socioeconomic status, or geographic location (e.g., from rival school, different state, rural area, city, etc.).

"Intimidation/Menacing" includes, but is not limited to, any threat or act intended to: place a person in fear of physical injury or offensive physical contact; to substantially damage or interfere with person's property; or to intentionally interfere with or block a person's movement without good reason.

"Staff" includes all school employees and Board members.

"Third parties" include, but are not limited to, coaches, school volunteers, parents, school visitors, service contractors, vendors, or others engaged in District business, and others not directly subject to school control at inter-district or intra-district athletic competitions or other school events.

Children from households whose income is at or below the levels shown are eligible for free and reduced price school meals.

Application forms are being sent to all homes with a letter to parents or guardians. To apply for free or reduced price meals, households should fill out the form and return it to the school. Additional copies of the application form are available at the principal's office in each school. Households should answer all questions on the form.

NON FOOD STAMP HOUSEHOLDS: An application which does not contain all of the following information cannot be processed by the school: (1) the total income by source for each household member (such as wages, child support, etc.); (2) names of all household members; (3) social security number of the adult household member who signs the application; and (4) the signature of a household member.

FOOD STAMP/FIP/FDPIR HOUSEHOLDS: If you currently receive Food Stamps, Family Independence Program (FIP), or Food Distribution Program on Indian Reservation (FDPIR) benefits for your child, you only have to list your child's name and Food Stamp or FIP/FDPIR case number and sign the applica-

The information provided by the household is confidential and will be used only for the purpose of determining eligibility, verifying data, or qualifying children for other federal and state programs, as authorized by the United States Department of Agriculture. The school or other officials may verify applications at any time during the school year.

Households may apply for benefits at any time during the school year. If a household is not currently eligible but has a decrease in household income, an increase in household size or if a household member becomes unemployed, the household should fill out an application at that time.

In most cases, FOSTER CHİLDREN are eligible for these benefits regardless of the household's income. If a household has foster children living with them and they wish to apply for free or reduced price meals for them, the household should contact the school for more information. Under the provisions of the policy, a designated administrator will review applications and determine eligi-

Parents or guardians dissatisfied with the ruling of the official may wish to discuss the decision with the determining official on an informal basis. The household also has the right to a fair hearing. This can be done by calling or writing the superintendent of the respective district. Each school and the central office have a complete policy, which may be reviewed by any interested party.

REAPPLY: You may apply for meal benefits at any time during the school year. If you lose your job, if your income decreases, if your family size increases, if you begin Food Stamps or FIP/FDPIR, fill out an application at that time.
